

# **Affordable Senior Housing for Rent**



## THE ATRIUM AT SUMNER 99 NEWLY CONSTRUCTED UNITS AT 57 Marcus Garvey Blvd,

BEDFORD STUYVESANT BROOKLYN

Affordable senior housing, built to passive house standards, located in the Bedford Stuyvesant neighborhood of Brooklyn. The building has an indoor garden and atrium in the center, and a Program of All-Inclusive Care for the Elderly (PACE) center on the ground floor which tenants of the building will have the ability to join on a voluntary basis.

**Amenities:** 24-hour attended lobby, free broadband in common areas and units, resident building superintendent, on-site building manager, social service staff office, 2nd floor interior atrium garden, laundry on 2<sup>nd</sup> and 9<sup>th</sup> floor, multi-purpose community room, library/computer room, bicycle storage room, exercise room, two elevators, emergency pull cords and built-in air conditioners in each apartment, handrails in common areas. On-site social services. The project includes a Program of All-Inclusive Care for the Elderly (PACE Center) on the ground floor, which tenants of the building will have the ability to join on a voluntary basis.

This 190-unit building is being constructed through the Extremely Low & Low-Income Affordability Program (ELLA) of the New York City Housing Development Corporation, the Senior Affordable Rental Apartments Program (SARA) of the New York City Department of Housing Preservation and Development, and the Next Generation NYCHA Program of the New York City Housing Authority. 57 units in this project are set aside for formerly homeless individuals who are referred by city agencies and 33 units will be filled through direct referral from NYCHA's Section 8 and public housing waiting lists. The units listed in this notice are only those made available to the general public.

#### Who Should Apply?

Senior/Elderly Individuals or households who meet the income and household size requirements listed in the table below may apply. Qualified applicants will be required to meet additional selection criteria. Applicants who live in New York City receive a general preference for apartments. <u>Senior/Elderly</u> is defined as a household whose head, spouse, or sole member is at least 62 years of age at the time of application submission.

A percentage of units is set aside for applicants with disabilities:

- Mobility (5%)
  - Vision/Hearing (2%)

Preference for 33 units goes to:

- i. Eligible NYCHA public housing Residents in good standing
- ii. Current NYCHA Section 8 tenant-based voucher holders

#### How Do You Apply?

Apply online or through mail. To apply online, please go to <u>https://housingconnect.nyc.gov/PublicWeb/</u>. To request an application by mail, <u>send a self-addressed envelope</u> to: **Atrium at Sumner, PO Box 440, Wading River, NY 11792.** Only send one application per development. Do not submit duplicate applications. Do not apply online and also send in a paper application. Applicants who submit more than one application may be disqualified.

#### When is the Deadline?

Applications must be postmarked or submitted online no later than <u>June 1, 2023</u>. Late applications will not be considered.

#### What Happens After You Submit an Application?

After the deadline, applications are selected for review through a lottery process. If yours is selected and you appear to qualify, you will be invited to an appointment of eligibility to continue the process of determining your eligibility. Appointments are usually scheduled from 2 to 10 months after the application deadline. You will be asked to bring documents that verify your household size, identity of members of your household, and your household income.
